

## SomerCor Small Business Improvement Fund (SBIF) SBIF Districts

*SBIF districts are Chicago tax increment financing (TIF) districts where the SBIF program is authorized. The SBIF program is available in roughly half of Chicago's TIF districts.*

### SBIF Application Acceptance Periods

To be accepted for possible funding, a [SBIF Application Form](#) for a project property must be submitted within a designated open application acceptance period for the TIF district in which the project property is located. Application acceptance period deadlines occur thirty (30) days after a public "roll-out" meeting announcing the availability of new funds or after an announcement via the SBIFGram (the monthly e-mail newsletter for the SBIF program). Applications for each open TIF district shall be accepted until 5:00 p.m. Central Time on the designated "close" deadline date. Currently open and "on-deck" (soon-to-be-open) districts and their respective application acceptance periods are listed below in the "SBIF-Authorized TIF Districts" section of this PDF.

Applications can be submitted via e-mail to [sbif@somercor.com](mailto:sbif@somercor.com), fax to 312-757-4371, U.S. Mail or other courier service, or hand delivery at 601 S. LaSalle St. #510, Chicago, IL 60605. Applicants are encouraged to contact SomerCor to confirm receipt of their application after submittal. All applications must be received by SomerCor by 5:00 p.m. Central Time on the application acceptance period "close" deadline date; any application that is postmarked before the application acceptance period "close" deadline date but not received by SomerCor 504, Inc. by 5:00 p.m. Central Time on the application acceptance period "close" deadline date shall not be accepted for possible funding.

***SomerCor cannot accept an application for a property that is not located in a Chicago TIF district. SomerCor cannot accept an application for a property that is located in a Chicago TIF district that does not have a currently open application acceptance period.***
